## Introduction to Job Manager

Job Manager allows you to schedule recurring processes for unattended operation. You can define file transfers for vendor services (such as credit reporting), Exchange processes, and AIM imports. You can also define a schedule to export files. Job Manager delivers and retrieves files using FTP, SFTP, FTPS, or file sharing. You can encrypt and decrypt files using Pretty Good Privacy (PGP) encryption. You can also specify email notifications to send to interested parties when file transfers are complete or when errors occur.

Job Manager supports the following components:

- **Job Service:** Windows service that runs on the server to poll one or more databases for jobs to start and run. LATITUDE by Genesys Support installs this service.
- **Exchange:** Application to import and export processes, and modify existing vendor service import mappings.
- **AIM:** Application to set up import and export configurations for outside collections agencies and attorneys.
- **WorkFlow:** Application to set up vendor requests for automatic processing.


## Log on to Job Manager

Use the **Interaction Collector Logon** dialog box to log on to Job Manager. There are no Job Manager permissions in Latitude. Therefore, only provide the Job Manager executable to users trained to use the product.

### To log on to Job Manager

1. Do one of the following:
  - On your desktop, click the shortcut to Job Manager.
  - Click **Start > All Programs > Interactive Intelligence > Interaction Collector > Job Manager**

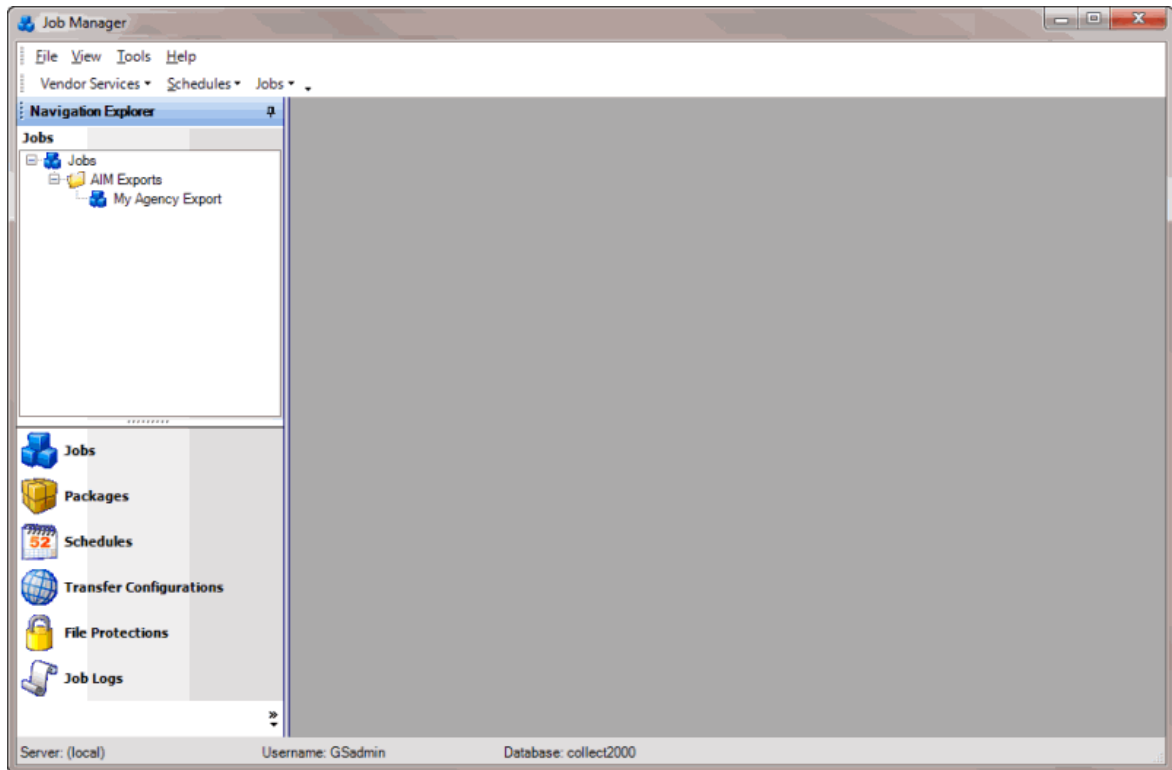
The **Interaction Collector Logon** dialog box appears.



2. In the **User Name** box, type your Latitude user name.
3. In the **Password** box, type your Latitude password. As you type your password, periods display instead of the typed characters.

**Note:** Premises-based clients can use Windows authentication to bind Latitude users to their Windows identity to permit logging on to Latitude automatically. Windows authentication is not available for hosted clients. To log on using Windows authentication, select the **Log in using Windows authentication** check box and provide your Windows user name and password.

4. Click **Okay**. The **Job Manager** window appears.

## Overview of Job Manager Window

Use the **Job Manager** window to configure jobs, packages, processing schedules, file transfers, and file encryption. You can also use the window to view job logs.

1. **Menu bar:** Displays available menu options and commands for the window.
2. **Navigation Explorer pane:** Displays the navigation for the window. Click a category in the **Navigation Explorer** pane (for example, Jobs, Packages). The options for that category appear. Double-click an item (for example, **New Job**) to display its information in the **Information** pane.
3. **Information pane:** When you click an item in the **Navigation Explorer** pane, the associated information appears in the **Information** pane.

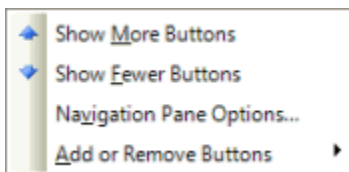

## Configure the Navigation Explorer Pane

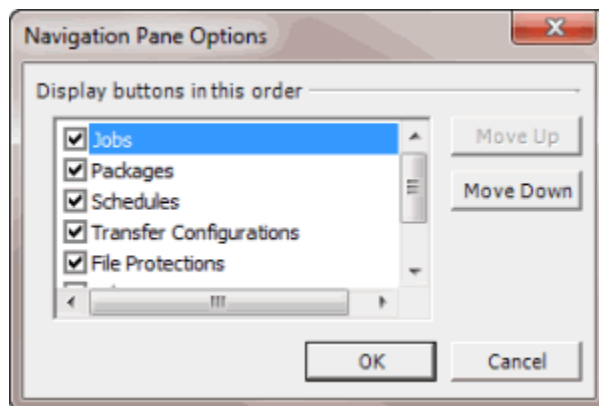
You can configure the **Navigation Explorer** pane to display or hide specific options, and change the order in which the options appear.

### To configure the Navigation Explorer pane

1. Near the bottom of the **Navigation Explorer** pane, click the double-arrows. The **Navigation Explorer** pane options appear.



2. To display more options, click **Show More Buttons**. The maximum available options appear.
3. To display fewer options, click **Show Fewer Buttons**. The available options that fit within the pane appear. All other available options appear as icons beneath the list.
4. To specify the order in which the options appear in the pane, do the following:
  - a. Click **Navigation Pane Options...**. The **Navigation Pane Options** dialog box appears.



- b. Click an option and then click **Move Up** or **Move Down**.
- b. When finished arranging the options, click **OK**.

**Note:** You can also select the check boxes for the options to display in the pane, and clear the check boxes for the options to hide in the pane.

5. To add or remove options from the pane, click **Add or Remove Buttons** and then click an option.

## Job Service

Job Service is a Microsoft Windows service that runs on the server to poll one or more databases for jobs to start and run. The service runs on workstations to export and import jobs according to their assigned schedules. Latitude by Genesys Support installs this service. Start or stop the service under the direction of Support only.

### To start or stop Job Service

1. Click **Start > Administrative Tools > Services**. The **Services** window appears.
2. Locate Job Service and then do one of the following:
3. To start Job Service, right-click **Job Service** and then click **Start**.
4. To stop Job Service, right-click **Job Service** and then click **Stop**.

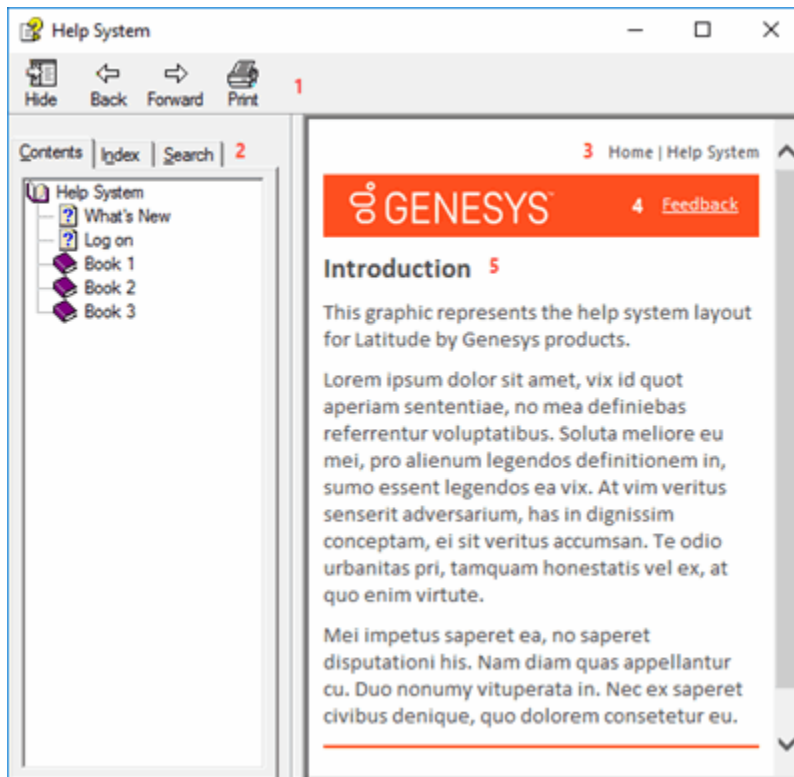

## Help Overview

Job Manager help provides you with information for using Job Manager. Click the **Help** option in the menu bar to open Job Manager help. Use the table of contents, index, and search features to locate and view a topic.

### To open help

In the menu bar, click **Help** and then click **Help on Job Manager**. The **Job Manager Help** window appears.



**Tip:** To adjust the width and height of the window or its panes, click the edge of the window or pane and drag it up or down, left or right.

1. **Toolbar:** Displays options for the help window.
2. **Tabs:** Displays the following:

**Contents:** Displays the table of contents. To display a topic in the **Content** pane, expand a book and then click the link.

**Index:** Displays the index. To display a topic in the **Content** pane, type a keyword or phrase in the box (or scroll through the list) and then click the link in the list.

**Search:** Displays the [search feature](#). To display a topic in the **Content** pane, type a keyword or phrase in the box and then press **Enter**. In the search results, click the link.

**Glossary:** Displays a list of terms and their definitions. To display a definition, click the term.

3. **Breadcrumbs:** Displays your current location within the help system. When you click a breadcrumb, the related topic displays.
4. **Content toolbar:** Displays an option to send feedback through an email message to Latitude by Genesys Documentation.
5. **Content pane:** Displays the contents of a topic. To view the **Content** pane menu, right-click in the **Content** pane.

## Search feature

You can use the search feature to search for topics that contain words or phrases that you specify. You formulate a search query following a specific [set of rules](#). You can include [wildcard expressions](#), [Boolean operators](#), and [nested expressions](#) in your search query. A list of topics that match your search criteria appear in the search results. When you click a topic title in the search results, the content of that topic appears in the **Content** pane.

## Search syntax

The basic rules for formulating search queries are:

- Searches are not case-sensitive, meaning you can type uppercase or lowercase characters.
- You cannot search for a single character or the following reserved words: an, and, as, at, be, but, by, do, for, from, have, he, in, it, not, of, on, or, she, that, the, there, they, this, to, we, which, with, you.
- The search engine ignores punctuation marks and special characters such as @#\$%^&()=+[ ]\.
- Enclose phrases and terms that include a period (such as a file name with an extension) in double quotation marks.

## Wildcard expressions

Wildcard expressions allow you to search for one or more characters using a question mark or asterisk. A question mark represents a single character, while an asterisk represents one or more characters.

Search for...	Example	Result
Topics with text that starts with one or more specified characters and ends in any character or number of characters	log or log*	Returns all topics with text that starts with the specified characters (for example, log, logon, logging).
Topics with text that starts with the specified characters, has a single character that can be anything, and ends in the specified characters	32?57	Returns all topics with text that has any character where you placed a question mark (for example, 32?57 returns 32257, 32457, and 32857).

Topics that contain all the words specified, in any order or placement within the topic	account status	Returns all topics with both account and status, but not necessarily as a phrase or in the order specified. For example, the search returns topics with "the account status..." or "the status of the account..."
Topics that contain the specified phrase	"account status"	Returns all topics with account status as a phrase. For example, the search returns topics with "the account status..." but not "the status of the account..."

### Boolean operators

Boolean operators (AND, OR, NOT, NEAR) allow you to create a relationship between terms. If you don't specify an operator, the system uses AND by default.

Search for...	Example	Result
AND	account AND status	Returns all topics with both account and status, but not necessarily as a phrase or in the order specified. For example, the search returns topics with "the account status..." or "the status of the account..."
OR	account OR status	Returns all topics with either account or status, or both.
NOT	account NOT status	Returns all topics with account but not status.
NEAR	account NEAR status	Returns all topics where account is within eight words of status.

### Nested expressions

Nested expressions allow you to perform complex searches. For example, queue AND ((collector OR clerical) not supervisor) finds topics containing queue and collector but not supervisor, or containing queue and clerical but not supervisor. As with mathematical expressions, the system evaluates expressions in parentheses first. If there is no parenthesis, the system evaluates the expression from left to right. For example, queue NOT (clerical OR supervisor) finds topics containing queue but not clerical or supervisor. Queue NOT clerical OR supervisor finds topics containing queue but not clerical, or topics containing supervisor.

### Transfer Configuration

Use the **Transfer Configurations** panel in the **Navigation Explorer** pane to create and maintain folders to organize transfer configurations. From this panel, you can open the **Transfer - [Transfer Configuration Name]** tab in the **Information** pane to add, modify, and test a transfer configuration. All jobs require a transfer configuration to specify how Job Manager sends and receives files. If the transfer configuration settings for a vendor package are the same for import and export jobs, you can set up one transfer configuration and use it for both jobs. If the settings differ, create a separate transfer configuration for each job.

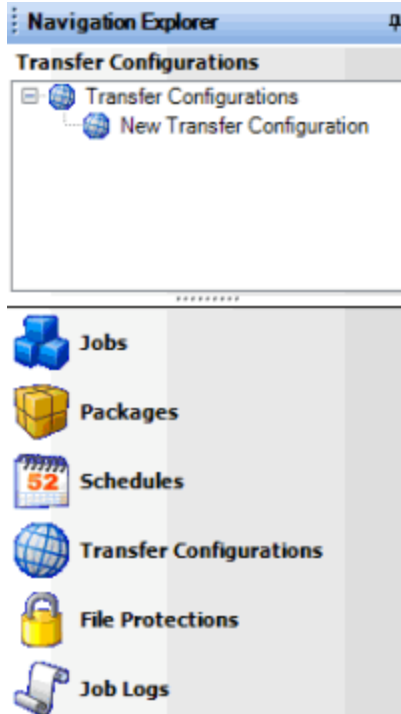
### Create a Transfer Configuration

Use the **Transfer - [Transfer Configuration Name]** tab to create a transfer configuration that specifies how to send and retrieves files.

#### To create a transfer configuration

1. In the **Navigation Explorer** pane, click **Transfer Configurations**. The **Transfer Configurations** panel appears.





2. To create a folder for the new transfer configuration, do the following:
  - a. Right-click **Transfer Configurations**, click **Add**, and then click **Add Folder**.
  - b. Type a name for the folder and then press **Enter**.
3. Right-click the folder where you want to add the transfer configuration, click **Add**, and then click **Add Transfer Configuration**.
4. Type a name for the transfer configuration and then press **Enter**.
5. Do one of the following:
  - Right-click the transfer configuration and then click **Transfer Configuration Properties**.
  - Double-click the transfer configuration.

**FTPS:** File Transfer Protocol Secure. Job Manager transfers files securely using SSL encryption.

**Fileshare:** Job Manager retrieves files from and saves files to a shared drive. If the remote directory is the C: drive, it must be a shared drive.

**Username:** User name for logging on to the transfer site.

**Password:** Password for logging on to the transfer site.

**Port:** FTP port on the recipient's side to store the files that Job Manager sends and retrieves.

**Host Server (URL):** Address of the host server for the transfer site or file share.

**Upload File Name Expression:** Naming convention for the file that Job Manager creates and uploads. Include the following expressions as needed (for example, CA\_@DateTime(yyMMddss):

**@DayCounter(2)** - Creates a numeric counter. The (2) variable inserts a number between 0-99, in sequence for each sent file.

**@DateTime(yyyyMMddssmm)** - Inserts the date and time stamp as part of the file name. Job Manager modifies the (yyyyMMddssmm) variable to use the date stamp differently (for example, MMddss).

**Download File Name Expression (REGEX):** Syntax used to retrieve the file, with the following recognized regular expressions (for example, ^CA\_[0-9][0-9] [0-9][0-9] [0-9][0-9] [0-9][0-9].done):

- ^** - Start at the beginning of the file name
- [0-9]** - Represents any number
- \*,\*** - Represents any file name, any extension

**Local Directory** : Location on the local computer or network to store the files. Job Manager retrieves import files from this directory and saves export files to this directory.

**Remote Directory** :Remote location to store files (for example, the FTP site or file share).

**Rename Local File on Download:** Not used.

**Renamed Local File Name Expression:** Not used.

**Explicit:** If selected, Job Manager uses explicit mode for FTPS providers. For more information, contact your network administrator or outside collection agency or attorney.

**Passive** : If selected, Job Manager uses passivemode for FTP providers. For more information, contact your network administrator or outside collection agency or attorney.

**Pickup Mode** : If selected, Job Manager deletes files from the remote site after retrieval. If you don't have the permissions to delete files from the remote site, clear this check box.

**Overwrite** : If selected, Job Manager overwrites files with the same name on the remote and local sites.

6. Complete the information and then, in the toolbar, click **Save**.

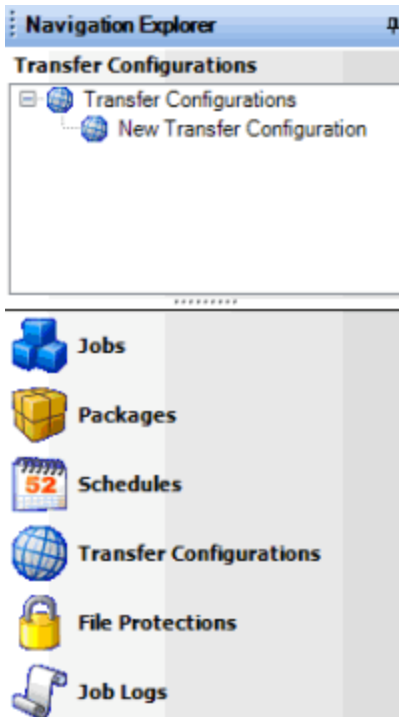


## Modify a Transfer Configuration

Use the **Transfer - [Transfer Configuration Name]** tab to modify a transfer configuration that specifies how Job Manager sends and retrieves files.

### To modify a transfer configuration

1. In the **Navigation Explorer** pane, click **Transfer Configurations**. The **Transfer Configurations** panel appears.



2. Do one of the following:

- Right-click the transfer configuration and then click **Transfer Configuration Properties**.
- Double-click the transfer configuration.

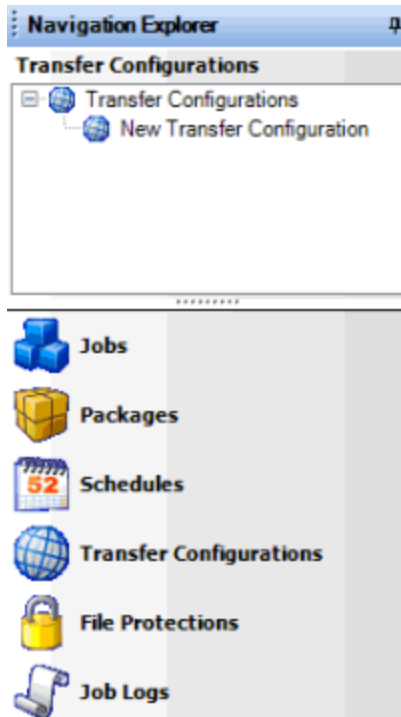


## Test a Transfer Configuration

Use the **Transfer - [Transfer Configuration Name]** tab to ensure that your organization configured the settings properly for connecting, uploading, and downloading files.

### To test a transfer configuration

1. In the **Navigation Explorer** pane, click **Transfer Configuration**. The **Transfer Configurations** panel appears.



2. Do one of the following:

- Right-click the transfer configuration and then click **Transfer Configuration Properties**.
- Double-click the transfer configuration.

The **Transfer - [Transfer Configuration Name]** tab appears. Job Manager includes the name of the transfer configuration in the tab name.

3. Do the following:
  - a. To test the connection settings, in the toolbar, click **Test** and then click **Connect**.
  - b. To test the file upload settings, in the toolbar, click **Test** and then click **Upload**.
  - c. To test the file download settings, in the toolbar, click **Test** and then click **Download**.

If any of the tests fail, Job Manager displays an error message. Click **OK**, modify the settings, and then retest.

### File Protection Configuration

Use the **File Protections** panel in the **Navigation Explorer** pane to create and maintain folders to organize file protection configurations. From this panel, you can open the **Protection - [File Protection Name]** tab in the **Information** pane to add, modify, or test a file protection configuration. This tab contains the PGP encryption codes that Job Manager uses to encrypt and decrypt files. You can specify a file protection configuration when defining a vendor package configuration.

Job Manager encrypts and decrypts files using independent software that creates public and private key files. To allow encryption and decryption, add these files to a file protection configuration. Request a public key from the outside party (for example, collection agency, attorney, or vendor) with whom you are sharing files. Add the public key received into the file protection configuration that Job Manager uses for the outside party's jobs. Add the public and private key that you generate locally. Send your public key to the outside party.

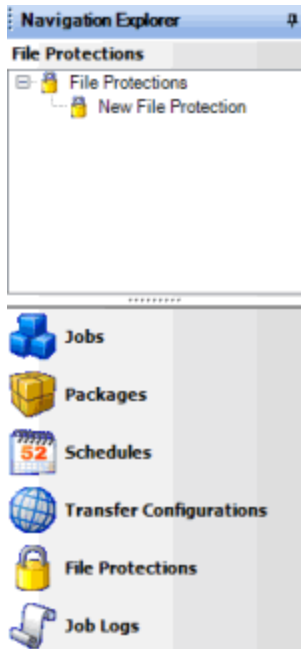

### Create a File Protection Configuration

Use the **Protection - [File Protection Name]** tab to create a file protection configuration to use to encrypt and decrypt incoming and outgoing files.

#### To create a file protection configuration

1. In the **Navigation Explorer** pane, click **File Protections**. The **File Protections** panel appears.



2. To create a folder for the new file protection configuration, do the following:
  - a. Right-click **File Protections**, click **Add**, and then click **Add Folder**.
  - b. Type a name for the folder and then press **Enter**.
3. Right-click the folder where you want to add the file protection, click **Add**, and then click **Add File Protection**.
4. Type a name for the file protection and then press **Enter**.
5. Do one of the following:
  - Right-click the file protection and then click **File Protection Properties**.
  - Double-click the file protection.

The **Protection - [File Protection Name]** tab appears. Job Manager includes the name of the file protection configuration in the tab name.

**Name:** Name of the file protection configuration as specified in the **File Protections** panel. To modify the name, rename it in the **File Protections** panel.

**Description:** Description of the file protection configuration.

**Local Passphrase:** Password to unlock your private key. Job Manager doesn't require you to establish a password.

**Load Local Public Key:** Key file that your company created. Outside parties use this key to encrypt files they send to your company.

**Load Local Private Key:** Key file that an outside party created. Job Manager combines this key with the outside party's public key to encrypt files your company sends to the outside party.

**Load Third Party Public Key:** Key file that an outside party created. Job Manager combines this key with the local private key to encrypt files your company sends to the outside party.

6. Specify the name and description, and optionally, the password to unlock your private key.
7. Do the following as necessary:
  - a. To add the public key, click **Load Local Public Key**. Click the file that contains the public key and then click **Open**.

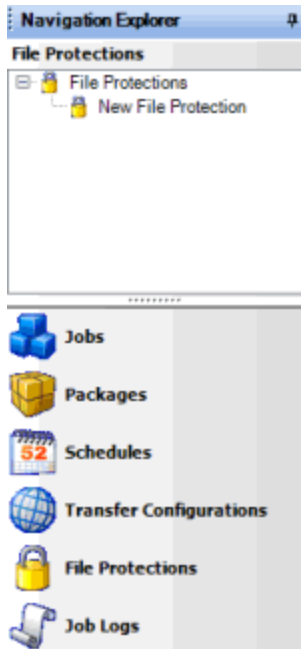

**Load Third Party Public Key:** Key file that an outside party created. Job Manager combines this key with the local private key to encrypt files your company sends to the outside party.

4. To add the public key, click **Load Local Public Key**. Click the file that contains the public key and then click **Open**.
5. To add the private key, click **Load Local Private Key**. Click the file that contains the private key and then click **Open**.

### Aggregate Functions

The following table describes the functions that are available when aggregating data. The functions available for an item are based on the item's data type.

Function	Description
Count	Counts the number of records for the grouping.

Sum	Totals the values within the grouping.
Average	Averages the values within the grouping.
Maximum	Calculates the highest value within the grouping.
Minimum	Calculates the lowest value within the grouping.
Standard Deviation	Averages the difference from the mean value of the entire set of accounts included.
Population Standard Deviation	Averages the difference from the mean value within the grouping.
Variance	Squares the standard deviation.
Population Variance	Squares the standard deviation within the grouping.
Eliminate Duplicates	Changes the equation to add the "distinct" clause. You can use this function with any aggregate after the initial selection.
Remove Aggregate	Deletes the aggregate function and returns the column to its literal value.

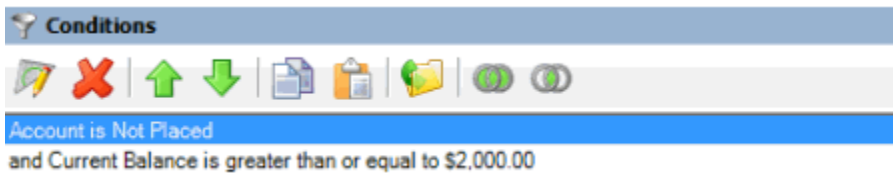

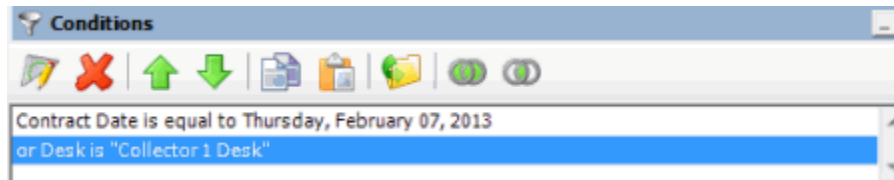
In the following example, both conditions must be true for an account to appear in the query results. So, if an account contract date is "February 7, 2013" and the Desk is "Collect 1 Desk," the query results include the account. If an account contract date is "February 7, 2013" but the Desk is not "Collect 1 Desk," the query results don't include the account. If an account contract date is not "February 7, 2013" but the Desk is "Collect 1 Desk," the query results don't include the account.



### OR condition

The OR condition sets a condition to optional.

In the following example, if an account contract date is "February 7, 2013" but the Desk is not "Collect 1 Desk," the query results include the account. If an account contract date is not "February 7, 2013" but the Desk is "Collect 1 Desk," the query results include the account. If an account contract date is "February 7, 2013" and the Desk is "Collect 1 Desk," the query results include the account. If an account contract date is not "February 7, 2013" or the Desk is not "Collect 1 Desk," the query results don't include the account.

### Query Condition Types

Each condition is one of the following types:

### Dates

Date conditions allow you to query accounts based on a [specific date](#), [date range](#), [any date or blank date](#), or [relative date](#). When you select a date condition, a dialog box displays to allow you to specify the

date criteria. The criteria available depends on the value you select in the **Value is** list box, and whether you select the **Relative** check box.

### Specific date

Use one of the following comparisons to evaluate accounts based on a specific date:

Value is	Description
Equal To	Retrieves accounts where the date matches a specific date.
Not Equal To	Retrieves accounts where the date does not match a specific date.
Later Than or Equal To	Retrieves accounts where the date matches or comes after a specific date.
Earlier Than or Equal To	Retrieves accounts where the date matches or comes before a specific date.
Later Than	Retrieves accounts where the date comes after a specific date.
Earlier Than	Retrieves accounts where the date comes before a specific date.

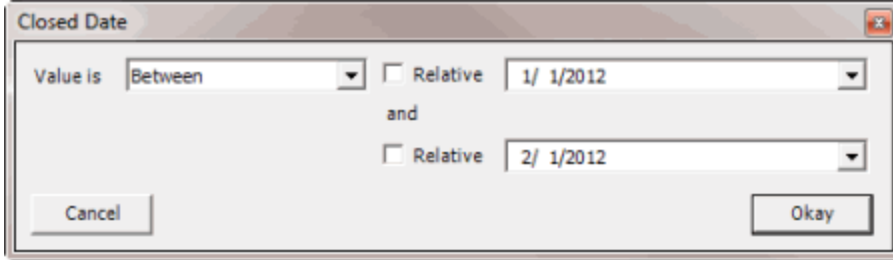
### Date range

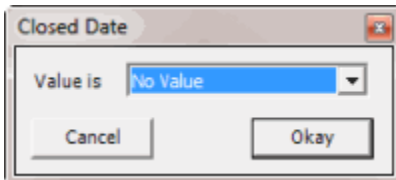


**Any date or blank date**

Use one of the following comparisons to evaluate accounts based on whether a date is blank or contains any value:

Value is	Description
No Value	Retrieves accounts where the date is blank.
Any Value	Retrieves accounts where the date is any date or blank.

In the following example, the system retrieves accounts where the **Closed Date** is blank (doesn't contain a value).



**Relative date**

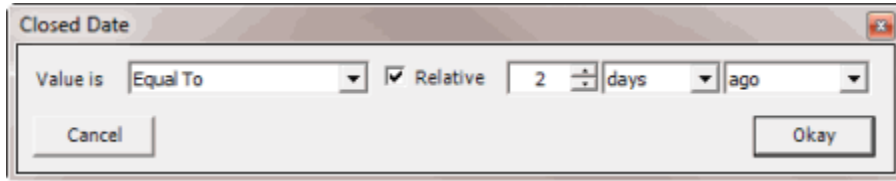
Use the relative date option to evaluate accounts based on the relation of a date to the current date. You specify a comparison and the criteria to use to calculate the relative date. The criteria are the number of days, months or years from the current date, and whether to add or subtract that number from the current date.

Use one of the following comparisons to evaluate accounts based on the calculated relative date:

Value is	Description
Equal To	Retrieves accounts where the date matches the relative date.
Not Equal To	Retrieves accounts where the date does not match the relative date.
Later Than or Equal To	Retrieves accounts where the date matches or comes after the relative date.
Earlier Than or Equal To	Retrieves accounts where the date matches or comes before the relative date.
Later Than	Retrieves accounts where the date comes after the relative date.

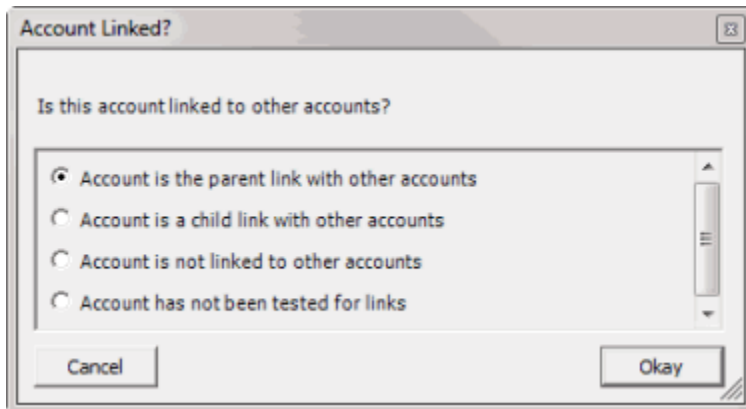
Earlier Than	Retrieves accounts where the date comes before the relative date.
--------------	---

In the following example, the system retrieves accounts where the **Closed Date** is two days before the current date.



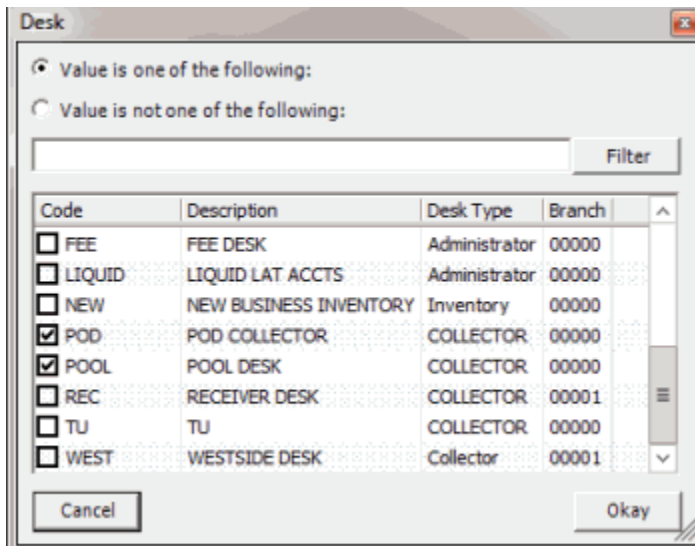
### Single option

Single option conditions allow you to retrieve accounts that match a single option in a group of options. In the following example, the system retrieves accounts that are the parent link to other accounts.



### Multiple option

Multiple option conditions allow you to retrieve accounts that match one or more options in a group of options. In the following example, the system retrieves accounts assigned to the POD desk and accounts assigned to the POOL desk.

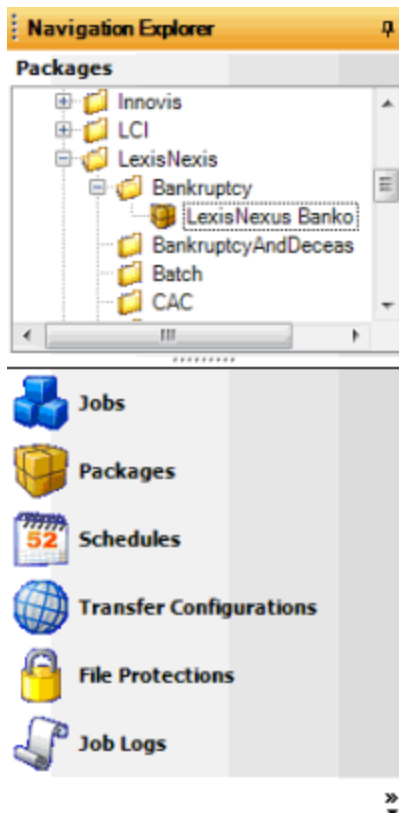

The package creates and sends vendor request files, and downloads and processes vendor return files. You can create several packages within the same folder based on different query criteria and extracted information. For example, you can set up a package to request vendor items for higher balance accounts or set up a package for accounts assigned to specific customer.

Before creating a vendor package, ensure that your organization defined the query configuration, transfer configuration, and, if necessary, file protection configuration.

**Note:** Maintain the import mapping for each package in Exchange. The Fusion folder in Exchange contains the Exchange vendor clients. Fusion imports files using these Exchange clients.

### Job Configuration

Use the **Jobs** panel in the **Navigation Explorer** pane to create and maintain folders to organize job configurations. From this panel, you can open the **Job - [Job Configuration Name]** tab in the **Information** pane to add or modify a job configuration. A job configuration consists of integrated components that vary based on the type of job (for example, Exchange, AIM, vendor services). A job is identified with the following (typically):

- **Schedule** - Defines when the job runs.
- **Transfer Configuration** - Defines the location of the files to process, and the file naming convention.
- **Package or Process** - Defines the encryption method and, for export jobs, the query that selects records for export. A package is for vendor services and a process is for Exchange or AIM.

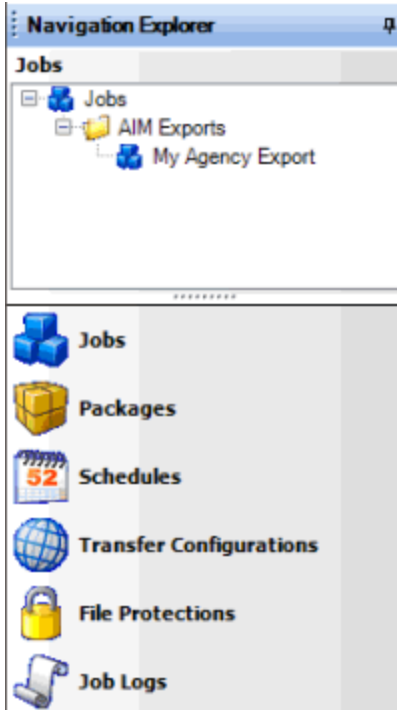



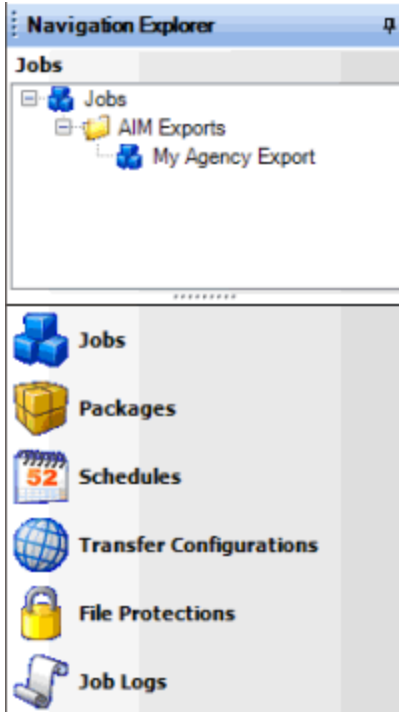

## Job Categories

Job categories define which packages and processes are available for selection when you create a job configuration. The following job categories are available:

- **AIM Export Job:** Automates exporting files to send to outside collection agencies and attorneys, based on settings in AIM.
- **AIM Import Job:** Automates importing files received from outside collection agencies and attorneys, based on settings in AIM.
- **AIM Placement Business Rule:** Automates placing accounts with outside collection agencies and attorneys, based on settings in AIM.
- **Command-Line Job:** Automates campaign building using the ListBuilder tool or automates executing a command that runs any application configured to accept command-line parameters.
- **Dialer Job:** Not used.
- **Exchange Export Job:** Automates export processes defined in Exchange.
- **Exchange Import Job:** Automates import processes defined in Exchange.
- **SQL Job:** Not used.
- **Vendor Service Export Job:** Automates creating and exporting files to outside vendors (for example, credit bureaus).
- **Vendor Service Import Job:** Automates importing files received from outside vendors (for example, credit bureaus).
- **Web API Job:** Automates updates to RDN cases for vehicle recovery or automates the execution of queries defined in Account Analysis or automates sending a POST request to any Web API endpoint.
- **YGC Export:** Not used. Automates exporting You've Got Claims files to send to attorneys, based on settings in AIM.

## AIM Jobs

You can use Job Manager to schedule export, import, or account placement processes that your organization defined in AIM to run automatically. Create a separate job configuration for each AIM agency and attorney that supports automation. Before creating a job configuration, ensure that your organization defined an export file layout, import file layout, or account placement business rule in AIM. For more information about AIM, see the AIM documentation.

### Exchange Jobs

You can use Job Manager to schedule Exchange jobs to run automatically. You define clients and export and import processes in Exchange before creating the job configuration in Job Manager. The process configuration can include one file type for one client, one file type for multiple clients, multiple file types for one client, or multiple file types for multiple clients. For example, a client can send you new business and financial updates in either a single file or two separate files. You define the transfer configuration (required) and file protection configuration (optional) in Exchange, and associate the configurations to the process in Exchange.

Usually, Job Manager processes export and import jobs independently of one another. Therefore, when you define an export job, Job Manager doesn't require you to define a corresponding import job.

### Create a Process Configuration in Exchange

The following table provides the high-level steps for creating import and export process configurations in Exchange. Define separate process configurations for imports and exports as a process configuration cannot contain both. You can, however, include up to four file types (for example, new business, financial transactions) in a process configuration. If you do include more than one file type, the order in which Job Manager processes files is important. For example, if you have a configuration that includes new business and financial transactions, order the new business import first. If the financial import runs

first and it contains accounts that are in the new business import, Job Manager doesn't update the new business records because they aren't in the system yet.

Step	Action
1	Create or open an existing process configuration.
2	Provide a name and description of the process configuration.
3	Select an owner client.
4	Select a transfer configuration.
5	If necessary, select a file protection configuration.
6	Indicate whether the process type is import or export.
7	Select a client and an interface (file type) to add to the configuration.
8	If necessary, select more clients and interfaces to add to the configuration.
9	If necessary, modify the order in which the processes appear in the data grid.
10	Save the process configuration.

### Create an Exchange Job

1	Job Manager	Create a transfer configuration for exchanging files with the client. You can use the same transfer configuration for export and import processes.

2	Job Manager (optional)	Create a file protection configuration to use when exchanging files with the client.
3	Exchange	Create clients to handle processing of files into or out of Latitude.
4	Exchange	Define an import or export process that specifies the process type, transfer configuration, file protection configuration (if necessary), clients, and file types.
5	Job Manager	Create a schedule that defines when the process runs.
6	Job Manager	Create a job that specifies the job category (based on the process type), process to run and the schedule.

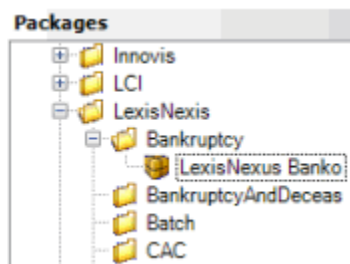
### Vendor Service Jobs



### Vendor Service Jobs

Vendor services include the multiple types of debtor and account information requested from outside sources that provide detailed information upon request. These services include skip tracing (update of debtor contact information), "scrubbing" for bankruptcy or deceased (probate) information, credit data and scoring, legal activity, and many others. Job Manager generates requests through exporting a file of information to the service, and importing the new or updated information received from the service provider.

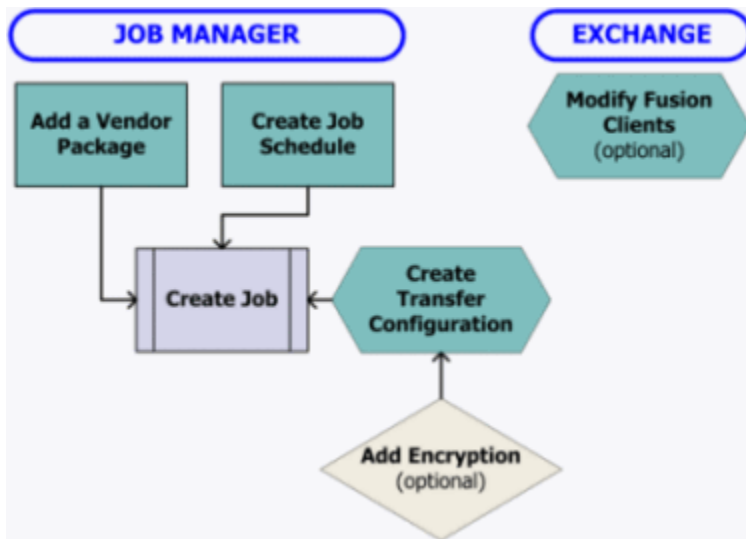
In Job Manager, you schedule vendor service jobs using packages to create request files, and download and process return files. Latitude by Genesys provides standard vendor service configurations that are displayed in Job Manager as folders in the **Packages** panel.



Your organization creates these configurations in Exchange as Fusion Clients (mapping configurations). The Fusion web service adds the configurations to Job Manager.

You create packages in Job Manager for each vendor service to which your organization subscribes. You can create multiple packages for a specific service, based on different query criteria and extracted information. For example, you can request more services from a vendor product for higher balance accounts or those accounts belonging to specific customers. Import jobs provide the information that an export job requested. Therefore, when you create an export job, Job Manager requires you to create a corresponding import job.

The following diagram represents the relationship between elements in Job Manager and Exchange when configuring a vendor service job.



Vendor service information returned through a vendor import job is displayed in Latitude for each account that has information. You can use the vendor Exchange client to map fields to update addresses, phone numbers, and other information in Latitude.

**Create a Vendor Service Job**

The following table provides an overview of the steps for creating a vendor service job. For more information, see [Job Configuration](#). Job Manager requires a separate job for vendor service exports and imports.

Step	Program	Action
------	---------	--------

1	Exchange (optional)	Modify vendor mapping for the product under the Fusion folder.
2	Job Manager	Create a vendor transfer configuration for uploading and downloading files with the vendor. You can use the same transfer configuration for both processes.
3	Job Manager (optional)	Create a file protection configuration to use when exchanging files with the vendor using PGP encryption keys.
4	Job Manager or Account Analysis tool in Latitude	Create and save a query to retrieve accounts that you want to include when exporting vendor package requests.
5	Job Manager	Create a package configuration for the vendor service, incorporating the transfer configuration and, if necessary, the file protection configuration.
6	Job Manager	Create a schedule for running the job.
7	Job Manager	Create a job for the Vendor Service Import or Vendor Service Export job category and specify the package and schedule configurations.

## Vendor Service Import Jobs

When you create and save a vendor service export job, Job Manager prompts you to create a corresponding import job. The vendor service import job is designed to check for information (import file) that the vendor created in response to the request (export) file. When Job Manager imports a vendor file, it updates information in Latitude. Exchange stores the mappings from the import file to Latitude as pre-configured clients in the Fusion folder.

Create the vendor service import job in the same way as the vendor service export job, with the following considerations:

- For identification purposes, include the vendor name, service, and the word "import" in the job name and description. (Use "export" for export jobs.)
- Specify **Vendor Service Import Job** as the job category.
- Specify the same package for import as for export.
- The path for uploading a request file can differ from the path for downloading a response file. If the paths differ, create a separate transfer configuration for the import job.

- The frequency with which Job Manager checks for a return file can differ from the frequency for exporting request files. If the frequency differs, create a separate schedule configuration for the import job.

### Vendor Service Configuration and Exchange

Exchange includes standard vendor services in the Fusion folder in the **Clients** panel. Latitude by Genesys established these clients to handle the creation of request files and processing of return files for specific vendor products.

All vendor clients exist as maintenance imports. Originally, these clients were designed to run using Fusion. If your organization upgraded to Job Manager, vendor service clients are available for scheduling as packages. Run vendor services using either Fusion or Job Manager, not both.

Data returned from vendors is available in Latitude for each account that has information. If you require special processing (for example, updates to addresses or phone numbers) you can modify the mapping or create a post-processing stored procedure.

### Fusion Jobs

Before Job Manager, Fusion was the only Latitude program available for exporting and importing vendor service files, and processing was manual. Job Manager automates the export and import tasks for unattended processing. If you use Job Manager, you no longer need Fusion.

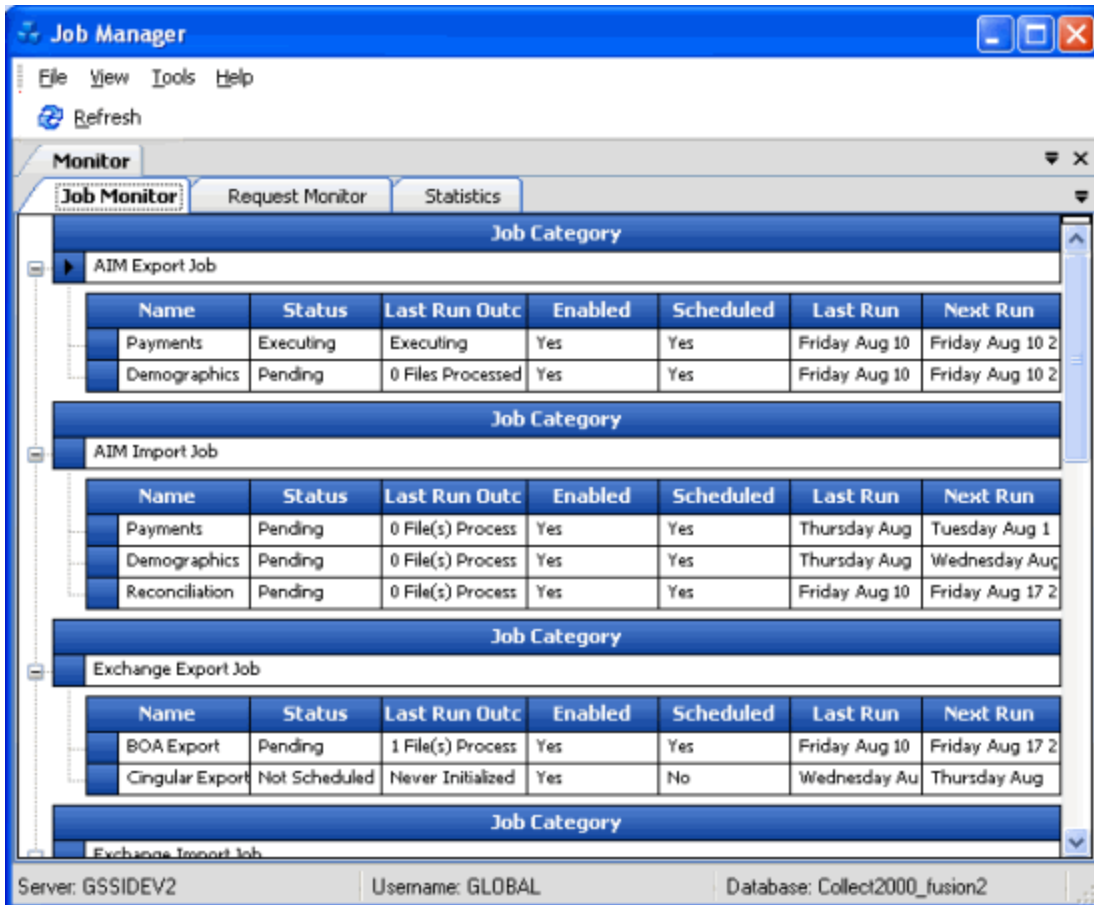

1. In the menu bar, click **View** and then click **Monitor Grid**. The **Monitor tab** appears in the **Information** pane. Jobs are grouped by job category.





**Name:** Name of the job.

**Status:** Status of the job.

**Last Run Outcome:** Results of the last job run. To view detail for an error that occurred during processing, rest your mouse on the error message.

**Enabled:** Indicates whether Job Manager allows the job to run.

**Scheduled:** Indicates whether the schedule is active for the job.

**Last Run:** Date Job Manager last ran the job.

**Next Run:** Date Job Manager scheduled the job to run next.

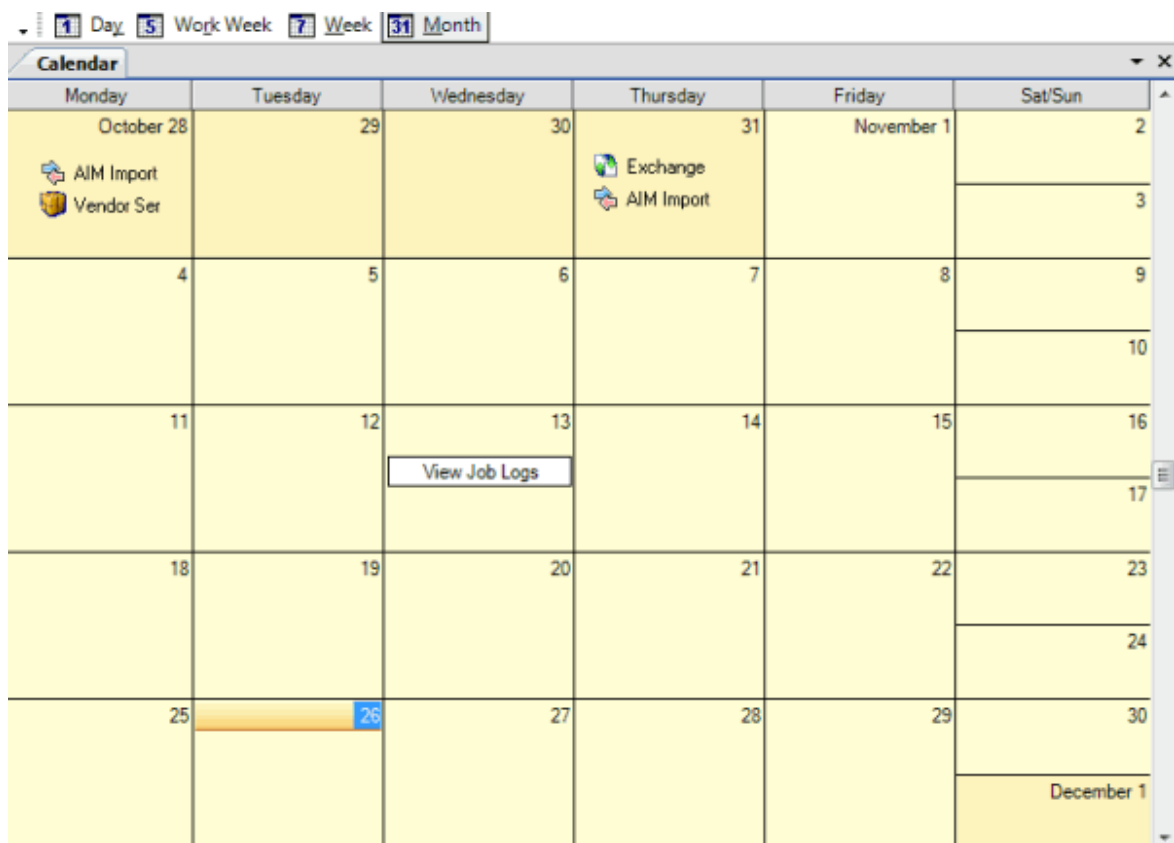


## View Scheduled Jobs in Calendar Format

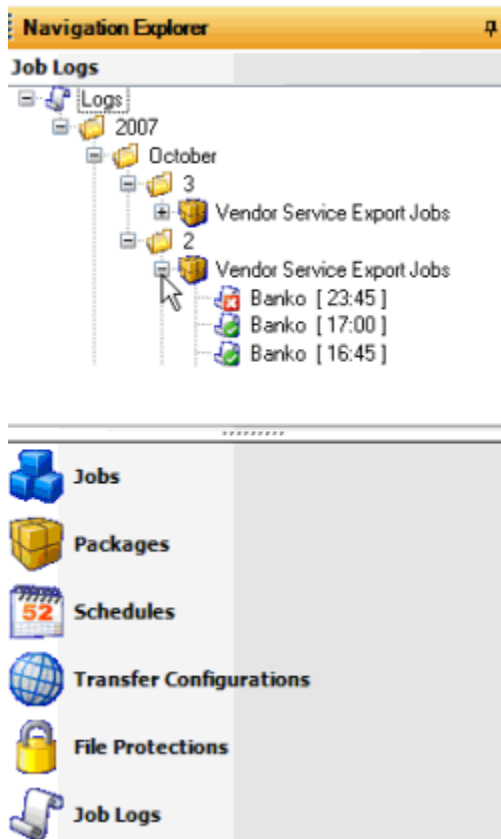

## View Files on the Local File Share

In each transfer configuration, you can specify a location to store a copy of the import or export file locally. You can use these copied files:

- As a backup if a job fails to place a file when an export job runs.
- As another source of processing history.
- To confirm that records are processing as required.

2. Verify that the files exist.

## Use Email to Monitor Activity

In each job configuration, you can specify one or more email addresses to receive notification when jobs complete successfully or produce an error. Best practices for email notifications are as follows:

- Email notifications for jobs that complete successfully are helpful for new jobs. You can discontinue the notifications once jobs run error-free routinely.
- Email notifications for failed jobs describe the failure in detail, which is useful for correcting the errors and running the job successfully. Specify at least one email address to receive notification for failed jobs.
